# CYNGOR TREF LLANFAIRFECHAN TOWN COUNCIL MINUTES OF THE FULL COUNCIL MEETING

1202. COOPTION FOR THE CASUAL VACANCY PANDY WARD.

Cllr Miss Sarah Jones left the room whilst this matter was discussed. Members were presented with a copy of letter/email sent in by Miss Nia Jones and Mrs Delhone Merrell. Miss Nia Jones was interviewed by members. Mrs Merrell had sent in her apologies as she had received a long awaited hospital appointment and would not be able to attend. A secret ballot was held in line with regulations. The votes were counted by the Town Clerk and verified by the Mayor Cllr Mrs Tamzin Hopwood. Miss Nia Jones received 6 votes and Mrs Delhone Merrell received 1 vote. The Chair declared Miss Nia Jones as the duly elected member for Pandy Ward.

Miss Nia Jones read out and signed her Declaration of Acceptance of Office, witnessed by the Town Clerk. Members congratulated Miss Nia Jones and welcomed her to the meeting.

- 1203. TO RECEIVE REPRESENTATIONS/QUESTIONS FROM MEMBERS OF THE PUBLIC. (Maximum of 5 minutes per speaker within a 20 minutes framework or at the discretion of the Chair).
  - i. <u>Invitation to trial dog licensing in your local area</u> The four members of the public present expressed their concern that the Town Council was proposing to trial a dog licensing in Llanfairfechan. It was stated that this was a private Company with an eye on profit, and that there were misleading quotes in the information letter. Members of the Council stated that this document was for information purposes only. It was imperative that such information was discussed and that members of the public were made aware of such schemes. New laws are coming into force in 2016 that all dogs must be micro chipped and have a collar and tag with owners contact details. Cllr Mrs Christine Roberts, who has been working voluntarily with the Dog Trust, stated that this was sufficient as there would be a data base to support the information.
  - ii. Streetlight at the old Station Road entrance to Bryn y Neuadd—it was stated that a streetlight is not working in this area which has led to antisocial behaviour, drug exchange and fly tipping. This was of grave concern to the owners of the adjacent property. These matters have been reported to the Police on numerous occasions. It was alleged that the land, where the out of order streetlight stands, was gifted to Bryn y Neuadd Estate by the Welsh Office. The residents have made complaints to Bryn y Neuadd but have not been successful in having the streetlight reinstated. It was requested if the Town Council would investigate this matter and report back to them.
  - iii. <u>Bont Stesion</u> It was stated that there are 2 conflicting weight limit signs on display for this bridge, and that large lorries and bus coaches are frequently turning and reversing onto the bridge. It was questioned would it be possible to have one of the signs removed.

Members also agreed that the Mayor Cllr Mrs Tamzin Hopwood and Cllr Andrew Hinchliff would oversee the project as the Town Clerk would be on annual holiday.

It is the Mayor's responsibility to keep records of his/her fundraising and expenditure and not for the Council to monitor, however for transparency the money will be paid into Town Council's account. The bench will be constructed by Smithy Fires; as a Director of the company Cllr Gareth Roberts left the room when this matter was discussed. **RESOLVED to receive and note.**

  - Local Council Advisory Service Annual Seminars 2014 and to consider becoming a members of the LCAS at annual cost £95 Town Clerk. Members received a verbal report on matters discussed. The Clerk recommended joining the LCAS as this was a valuable source of information and guidance regarding Risk Assessment. RESOLVED to approve to become members.
  - II. Nant y Coed Country Park In the absence of Town Council Representative Cllr Stuart Neesham, County Councillors Andrew Hinchliff and Ray jones gave a verbal report on matters discussed. It was stated that the maintenance work is proceeding well. The water is clear and the area encourages a natural habitat for wild life. A Hydro Turbine would not be feasible as there is no reservoir to constitute continued flow of water. **RESOLVED to receive and note.**
  - III. <u>Community Hall, Management Committee</u> A verbal report was presented regarding quotations for decorating the Council Chamber. Members were informed that a quote has been approved and an application for a grant will be forwarded to the Communities Officer in CCBC. **RESOLVED to receive and note.**

## 1234. TO RECEIVE REPORTS OF COMPLAINTS/CONCERNS/COMPLIMENTS

- i. <u>Public awareness notice</u> it was reported that there had been a spate of incidents of theft from garden sheds in the area.
- ii. Resurfacing Village Road County Cllr Andrew Hinchliff stated that the work would be carried out in sections, with traffic lights and diversion signs.
- iii. <u>Accident by Ysgol Babanod</u> it was reported the incident had been discussed at a Health and Safety meeting. This is a CCBC matter.
- iv. Cycle Path concerns that sand drift is blocking the track by Conwy Morfa. Matter reported to CCBC.
- v. <u>Bryn Teg footpath</u> reported the alley needs to be cleared of overgrowth.
- vi. <u>Cob wall</u> it was reported that the damage to the sea defence wall and the flat area by the woods are to be repaired.
- vii. Caradog Place reported overgrowth of hedge by the Bwthyn.
- viii. Razor Clam Pickers CCBC Officers had been alerted.
- ix. <u>Pendalar Estate</u> following complaints of antisocial behaviour a multiagency meeting has been arranged with local residents for the 8 August 2014. If there is poor attendance a house to house consultation will follow. It is proposed to have CCTV monitoring in place for an initial 6 months period.
- x. <u>Glan y Mor Elias</u> it was reported that the litter bin has been removed from the parking layby; this has led to an accumulation of rubbish in the surrounding area.
- xi. <u>Pont y Pentre</u> reports that due to vehicles parked on the corner it is making it difficult for passing traffic to negotiate the turning to Mill Road. CCBC Cllr Andrew Hinchliff will make enquiries with Highways to have yellow lines put in place.
- xii. Speeding cars it was reported that cars are being driven at speed around the town.
- xiii. <u>Promenade</u> it was reported that weeds along the sea defence wall had been removed from the bridge to the jetty but not in front of the Pavilion Café.
- xiv. <u>Parking by the Traffic Lights</u> it was reported owners of vehicles are parking on double yellow lines at the top of Station Road.
- xv. Litter Bin Promenade. It was reported that the damaged bin has not been replaced.
- xvi. Promenade Toilets reported there is still variance with the closing of these toilets.
- xvii. Cycle rack it was suggested an area to secure cycles was needed on the Promenade car park.
