178. **IN ATTENDANCE - Ela Williams, Community, Culture & Heritage Officer, CCBC regarding bidding for grant to re-surface the Car Park, Promenade and install Tourist Information interactive sign. Members discussed applying for the European Regional Development Fund (ERDF) to improve the car park as part of the regeneration for the area. The maximum amount that can be applied for is £128K with match funding of 20%. It was agreed that the area is a pivotal part of the community with many events held annually, it is also hoped to attract further attractions that will generate income and visitors. An interactive visitor's board advertising local businesses and events, with historical facts was considered desirable. Disabled access and improve the entrance to the car park was also discussed.
